The town has been doing this for seven years and it was very cold but also very nice.

## CORRESPONDENCE

- 1. The town received the attorney's invoice and it was much lower than anticipated. The board is waiting to receive the bill for the assessor's fees.
- 2. The Rural Fire Protection Task Force has increased its appropriation amount and according to town policy, it will need to provide a petition signed by 5% of the voters in order to be on the warrant. Bill Levine may bring it up at the next Fire Department meeting.
- 3. The Vermont League of Cities & Towns is offering a free webinar on Wednesday, December 10, 2025 from 10 a.m. to 11:30 a.m. on the Open Meeting Laws. She encouraged all board chairs and members to sign up and attend.
- 4. The Governor will be in Bennington tomorrow from 10:45 a.m. to 11:45 a.m. and will be meeting with fire chiefs, police chiefs and Select Board members regarding public safety in our communities. Mike Denault felt the town has more police coverage now from the state police than when the town paid for the Bennington Sheriff, and there is no cost to the town.
- 5. Mike Denault acknowledged two emails the board received, one questioned that the appointment of the Zoning Administrator to the Planning Commission was a conflict of interest, and the other questioned if it was a conflict to have a Select Board member work as the Assessor Clerk. Mike Denault has done some research and neither positions are incompatible and they can be held by the same person, but he wanted to acknowledge the emails and resolve the complaints.

## PLANNING COMMISSION

Jim Stimpson stated that the Planning Commission work sessions have been going well at The Center. The meetings are warned and are open to the public. Nancy Bushika asked if he felt the location or time of day affected attendance. Jim Stimpson said that members of the public have attended their meetings.

You can choose how you would like to be alerted (phone call, text or email) and can choose what type of alerts you would like to receive, i.e. weather, road closures, public health, etc.

- 3. 911 House numbers must be affixed to your home or the entrance of your driveway to be compliant with state law.

The deadline for filing petitions with the town clerk for warrant articles to be included in the town meeting warning is Thursday, January 15, 2026. These petitions must be signed by 5% of the registered voters or at least 38 signatures. V.S.A. 17:2642(a)

The required signatures on a petition to run for an elected office are 1% of the registered voters or at least 8 signatures. The deadline for filing these petitions with the Town Clerk is Monday, January 26, 2026 by 5:00 p.m. Nominating papers and the Consent of Candidate form may be picked up at the Town Office. V.S.A. 17:2681(a) (b).
